- -Ron discussed the Blaine Wilson Classic. The Wilson committee have not had their final meeting (scheduled for April 7<sup>th</sup>), so they have not "closed the books" on the meet yet. Ron stated that he thinks that there will be around \$1,500 going to the state.

- -Ron stated that he would like a deadline for all sanctions to pay to the state.
